

## **Overcomers' Community Monthly and Annual Giveaway Official Rules**

1. Eligibility: The Overcomers' Community monthly and annual giveaway (OCMAG) is open to any person who registers at <https://community.beinhealth.com/>. Entrants must be 18-years of age or older as of their date of entry in this promotion in order to qualify. This OCMAG is completely free to enter for everyone that visits the above web site, no membership or login required. Paid team members of Hope of the Generations Church, Be in Health, Overcomers Academy, Association of Churches Teaching and Serving, and Pioneer Village, as well as members of a team member's immediate family and/or those living in the same household of team members are ineligible to participate in the **OCMAG**.

2. Sponsorship. The sponsor is Hope of the Generations Church ("Sponsor"), located at 4178 Crest Highway, Thomaston, Georgia 30286. Sponsor will conduct the OCMAG substantially as described in these Official Rules.

3. Agreement to Rules: By entering this OCMAG, the entrant ("You" or the "Entrant") agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserves the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor's sole discretion. **By** entering this **OCMAG** You represent and warrant that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this **OCMAG**.

The exact resource that will be available to win will be shown on the banner of the Overcomers' Community home page on the first of each month and will remain displayed on the home page all month long. Resources will be given in the recipient's choice of available formats, which effects the retail value of the gift. A physical copy of the resource is available for shipment only within the Continental United States, all others will receive a digital copy. The monthly drawing will be held on the first business day after the end of each month. The winner will be notified via text and e-mail. Also, the winners name will be published on the Home Page feed of the Overcomers' Community.

All of the monthly entries each month will be added to an annual drawing for the opportunity to win one of the end of year gifts. There are three end-of-year gifts:

- A. The grand prize gift is two no cost tuitions to any retreats offered by Be in Health at the Hope of the Generations campus, no cost accommodations at either the Hope Inn or Hope Farm and Campground for up to 2-accommodations or 2-weeks, and a \$500 pre-paid credit card to help cover food and travel expenses. A value of \$1,672 to \$2,606 depending upon the number of retreats, which retreat and whether accommodations are joint or separate. The tuitions pre-pays and

accommodations have no cash value, they may be transferred by the recipient to any other person, and they must be used during the 2025 calendar year. Travel and food expenses over and above the \$500 pre-paid credit card are the responsibility of the recipient.

- B. The first runner up gift is two no cost tuitions to any retreat offered by Be In Health at the Hope of Generations Church Campus. Two people may attend either the For My Life, Walk Out Workshop or the For My Life eXpanded retreat in Thomaston for \$0 tuition. Or one person may attend two different retreats. A value of \$578 to \$918 depending up the number or retreats and which retreat is attended. The tuition pre-pays have no cash value, they may be transferred by the recipient to any person, and they must be used during the 2025 calendar year. Travel, food and lodging expenses are the responsibility of the recipient and You must stay at either the Hope Inn or the Hope Farm and Campground while attending the retreat(s).
- C. The second runner up gift is an annual membership in the Overcomers' Community at no cost beginning in 2025. A value of \$274.89.

The annual drawing ends on December 31, 2024 at 11:59 PM. The annual drawing will be held on the first or second business day after the New Year. The winners will be notified via text and e-mail. There is no limit to the number times You can win in a calendar year. You could win each month if your name is drawn. Also, if You win the December monthly drawing You may also win one of the gifts for the annual drawing. 7. Odds: The total number of eligible entries received determines the odds of winning.

Selection and Notification of Winner: The Winner will be randomly selected electronically from the entire list of entries for the month and for the annual drawings under the supervision of the Sponsor. The Sponsor will notify the Winner(s) by text to their mobile number and e-mail within five (5) days following the winner selection. Also the winners name will be published on the home page of the Overcomers' Community.
